TRANSPARENCY OF SUSTAINABILITY RISK POLICIES

Nordic Capital has implemented a Responsible Investment Policy, which sets out, amongst other matters, how sustainability risks are integrated into its investment decision-making process. For further information, please review our Responsible Investment Policy. For the purposes of the SFDR, a sustainability risk is an environmental, social or governance (ESG) event or condition that, if it occurs, could cause an actual or a potential material negative impact on the value of the investment.

Nordic Capital has a well-established Responsible Investment Policy to ensure high environmental, social, and corporate governance standards from sourcing to exit. Nordic Capital is a signatory to the United Nations-supported Principles for Responsible Investment Initiative (PRI). As a signatory, Nordic Capital commits to taking active ownership of ESG integration into its policies and practices, reporting on activities and advancements within the firm and portfolio-level, and promoting responsible investment practices throughout the investment management industry. Together with other PRI signatories, Nordic Capital continues to adapt our investment activities to the changing imperatives impacting our companies, our communities, and our climate.

TRANSPARENCY OF ADVERSE SUSTAINABILITY IMPACTS AT ENTITY LEVEL

We have chosen not to do so for the present time, since we consider our existing due diligence process and Responsible Investment Policy to be appropriate and proportional to the investment strategies of our funds.

We continue to monitor regulatory developments with respect to the SFDR and other applicable ESG-focused laws and regulations, including the implementation of related and secondary legislation and regulatory guidance and will, where required or otherwise appropriate, make changes to our existing policies and procedures.

Nordic Capital has an approach to remuneration that is consistent with sound risk management, which we consider including the management of sustainability risks in our investments. The performance evaluation and compensation framework for our investment teams and, where applicable, other personnel take into account a range of criteria, including adherence to our due diligence procedures that are designed to identify and mitigate the risks inherent in each of our investments, including sustainability and other ESG-related risks identified and managed pursuant to our Responsible Investment Policy.
